

As an extra service, Bink offers the possibility of bringing your child to swimming lessons. Bink arranges transport to the swimming pool, supervision in the changing room and handing over your child to the swimming instructor. We work together with several swimming schools in Hilversum and Soest. You arrange registration for and payment of swimming lessons with the swimming pool yourself.

### How does this service work?

Step 1: read below in our general information whether your child is eligible for swimming transport; Step 2: check our <u>registration page</u> to see on which days we transport to which swimming pool;

Step 3: Once your child is registered at the swimming school and you know on which day and time your child will be swimming, fill in the application form for transport to the swimming club on our website;

Step 4: Then our transport planner will let you know when your child will be transported to the swimming club. NB: transport is only possible if enough buses and drivers are available.

#### General information:

- Bink's role involves transportation to the pool, supervision in the changing room and handing over your child to the swimming instructor;
- Children from 4.5 years old can join the swimming transport;
- Children can join until they obtain their A-diploma. If you want your child to continue swimming for the B-diploma, sign up again with the transport coordinator. Children who are on the waiting list for their A-diploma take precedence;
- Placement in a swimming class and the corresponding training time are arranged by the swimming association. Bink has no influence on this;
- If your child's swimming time or day changes, please contact our transport planner to discuss the possibilities; for Hilversum click <a href="here">here</a> and for Soest click <a href=here</a>;
- If your child does not go with the transport, please let the out-of-school care manager know in time or e-mail our transport planner before 11 am on the day of the change; for Hilversum click <a href="here">here</a> and for Soest click <a href="here">here</a>
- Bink does not arrange transport during school holidays;
- Bink is not liable for loss of and/or damage to your child's clothing or other personal belongings while on the swimming club's premises;
- You enter into an agreement for swimming lessons with the swimming pool. Bink does not accept any
  liability for the execution of the swimming lesson and possible damages resulting from the swimming
  lesson. The swimming pool is at all times responsible for your child during swimming lessons

# From the out-of-school-care centre to swimming lessons, the way we do it:

- Transport to swimming lessons is only possible if the swimming lesson ends no later than 18.15;
- Your child will be picked up at the out-of-school-care centre by one of our drivers;
- Your child is signed out at the out-of-school-care centre on departure;
- Bink's drivers bring the children to the pool and hand them over to the swimming instructor. Bink's supervision and responsibility ends upon handing over to the swimming instructor;
- During swimming lessons, the children are the responsibility of the swimming pool instructors.

### From swimming lessons back to the out-of-school centre, how do we do it?

- In some cases, the driver brings the children back to their own out-of-school-care location after the swimming lesson. Bringing children back to the out-of-school-care location is only possible if the swimming lesson ends before 5.30 pm. Of course, you can also collect your child from the swimming lessons yourself. If your child is being collected by someone other than yourself, please inform the centre. If you do not do this, the driver is not allowed to pick up your child and will take your child back to the out-of-school-care location;
- Bink's responsibility begins again when the swimming instructor hands over your child to the Bink staff member:
- On returning at the out-of-school-care centre, your child will be registered again.

# What do we ask of you as a parent?

- Please go through the above relevant arrangements with your child in advance;
- If there are any (medical) details that our drivers need to know about, please let us know;
- Visit the swimming club with your child beforehand, so that your child knows where to go;
- Make sure you have the right swimwear.
