

General information:

- Bink's role concerns transport to the sports club only. No Bink staff member is present during the training.
- Our driver or pedagogical staff member, an employee employed by Bink, takes the children from the out-of-school location to the entrance of the sports ground/gym. The children walk independently, i.e. unaccompanied, to their sports activity.
- Placement in a team and the corresponding training time are arranged by the sports club. Bink has no influence on this.
- As soon as you know what day and time your child will train, fill in the online application form for transport to the sports club on our website.
- Our transport planner will then inform you when your child will be transported to the sports club. NB: transport is only possible if enough buses and drivers are available.
- If your child's training time or training day changes, please contact our transport planner to discuss the possibilities, for Hilversum click here and for Soest click here.
- If, one day, your child will not make use of the transport, please let the out-of-school care manager know this in time or e-mail our transport planner before 11:00 on the day of the change, for Hilversum click here and for Soest click here.
- During school holidays, winter and summer breaks, Bink does not arrange transport.
- Bink is not liable for loss of and/or damage to your child's clothing or other personal belongings while on the sports club premises.
- This arrangement applies per school year, so we therefore ask you to re-register your child for the new season.

From the out-of-school care location to the sports club, how do we do this:

- Transport to training sessions is possible only if training starts before or at 16:00.
- Your child has to change in the appropriate sportswear at the out-of-school care location. Make sure they wear comfortable clothes on these days.
- One of our drivers will pick up your child at the out-of-school care location. Bink's drivers drive back and forth to ensure that the children are present on time.
- Your child will be signed out at the out-of-school care centre on departure.
- Upon arrival at the sports club, the children walk independently to the training fields. The Bink's drivers do not take the children to their training grounds. Bink's supervision and responsibility ends when the children get off the bus.
- No Bink employee is present during the time your child is training.
- During training, children are the responsibility of the trainers of the sports club.



From the sports club back to the out-of-school care location, how do we do this:

- Our driver takes if possible the children back to the out-of-school care centre if the training ends at 17.00 (or earlier). If training ends later than 17.00, you have to pick up your child yourself. You can, of course, always collect your child from the sports club yourself. If your child will be picked up by someone other than yourself, please inform the out-of-school care location. If you do not do this, the driver is not allowed to give permission to the other person pick up your child and will take him/her back to the out-of-school care location.
- The driver will wait with the bus in front of the entrance to the sports complex.
- After training, children walk independently to the bus that will take them back to the out-of-school care centre. Bink's responsibility begins again upon boarding the bus.
- On arrival at the out-of-school care location, your child will be signed in again.

What do we ask of you as parents?

- Please go through the above relevant arrangements with your child in advance.
- If there are any (medical) particularities our drivers need to know about, we would like to be informed.
- Visit the sports club with your child beforehand, so he/she will know where to go.
- Make sure you have appropriate sportswear. If children do not bring sportswear, the sports club will not allow them to participate in the training and we cannot transport them.
- Discuss with your child in advance where at the sports ground he/she can report in case of any particularities.
