

## New rate play groups as of January 1st of 2019 – Soest



Dear parent(s), caregiver(s),

Please find our new rate for 2019 and our additional conditions below. Due to the late decision of the municipality, our rates are only now known, for which we apologize.

Because our costs will rise in 2019, our rate will be slightly higher this year. Bink is a non-profit social organisation. This means that our playgroups do not have to make a profit, but we do have to cover our costs.

### What will be the new hourly rate?

The new rate will be € 9.17. Your own contribution depends on whether you are entitled to childcare allowance or a subsidy from the municipality.

1. If you receive **childcare allowance**, see **point 1**.
2. If you receive **subsidy**, see **point 2**.

The rates apply from 1 January 2019. You pay for 40 weeks of childcare per year. The parental contribution is invoiced in twelve equal instalments

## 1. I receive childcare allowance. What will be my hourly rate?

If you are entitled to childcare allowance from the Tax and Customs Administration, the new hourly rate will be € 9.17.

### VVE (early childhood education) indication

If your child has a VVE place, he or she is entitled to four half-days of playgroup. The third and fourth parts of the day are free of charge.

### More childcare allowance in 2019!

Good news! In 2019, the government will invest an extra 248 million in the childcare allowance. As a result, most parents will benefit next year.

The maximum hourly rate for which you can apply for childcare benefit will be in 2019:

Childcare € 8.02 (2018: € 7.45)

## 2. I receive a municipal subsidy. What will be my own contribution?

Parents who are entitled to a municipal subsidy pay a personal contribution for the playgroup. The amount depends on your income. You can read in the table below what this means for your situation.

Family income 2019	Parental contribution 2019 per month (1st child)
€ 0 – € 25,263	€ 0.00
€ 25.264 – € 29,879	€ 36.16
€ 29.880 – € 41,116	€ 46.89
€ 41.117 – € 55,924	€ 58.09
€ 55.925 – € 80,387	€ 80.96
€ 80.388 – € 111,393	€ 118.75
More than € 111,394	€ 150.71

When you receive a subsidy, you don't have to do anything. Bink processes the change in the rate

**Please note** that from 2019 onwards, a subsidy from the municipality must be applied for at Bink and no longer at the municipality.
